







## SPC-1 Storage Capacities

The Physical Storage Capacity consisted 9,602.112 GB distributed over 24 solid state storage devices (SSDs), each with a formatted capacity of 400.088 GB. There was 0.00 GB (0.00%) of Unused Storage within the Physical Storage Capacity. Global Storage Overhead consisted of 141.734 GB (1.48%) of the Physical Storage Capacity. There was 454.065 GB (4.80%) of Unused Storage within the Configured Storage Capacity. 




### SPC-1 Storage Capacity Charts

Each Test is an atomic unit that must be executed from start to finish before any other Test, Test Phase, or Test Run may be executed.

## "Ramp-Up" Test Runs



#### Sustainability – Data Rate Distribution Graph




#### Sustainability – I/O Request Throughput Distribution Data

## Sustainability – I/O Request Throughput Distribution Graph




#### Sustainability - Average Response Time (ms) Distribution Data

Sustainability Average Response Time Table


#### Sustainability - Average Response Time (ms) Distribution Graph



## IOPS Test Run – I/O Request Throughput Distribution Data




# IOPS Test Run – I/O Request Throughput Distribution Graph

# IOPS Test Run – Average Response Time (ms) Distribution Data




### **IOPS Test Run – Average Response Time (ms) Distribution Graph**





# **Repeatability Test**

The Repeatability Test demonstrates the repeatability and reproducibility of the SPC-1 IOPS<sup>™</sup> primary metric and the SPC-1 LRT<sup>™</sup> metric generated in earlier Test Runs.



## Repeatability 1 LRT – I/O Request Throughput Distribution Graph










# Repeatability 2 LRT – I/O Request Throughput Distribution Data




# Repeatability 2 IOPS – I/O Request Throughput Distribution Data

- Ensures the transfer of data between Logical Volumes and host systems occurs without corruption or loss.

The SPC-1 Workload Generator will write 16 block I/O requests at random over the total Addressable Storage Capacity of the TSC for ten (10) minutes at a minimum of 25% of the load used to generate the SPC-1 IOPS<sup>TM</sup> primary metric. The bit pattern selected to be written to each block as well as the address of the block will be retained in a log file.

The Tested Storage Configuration (TSC) will be shutdown and restarted using a power off/power on cycle at the end of the above sequence of write operations. In addition, any caches employing battery backup must be flushed/emptied.

The SPC-1 Workload Generator will then use the above log file to verify each block written contains the correct bit pattern.

- 1. A listing or screen image of all input parameters supplied to the Workload Generator.

If approved by the SPC Auditor, the SPC-2 Persistence Test may be used to meet the SPC-1 persistence requirements. Both the SPC-1 and SPC-2 Persistence Tests provide the same level of functionality and verification of data integrity. The SPC-2 Persistence Test may be easily configured to address an SPC-1 storage configuration. The SPC-2 Persistence Test extends the size of storage configurations that may be tested and significantly reduces the test duration of such configurations.

The SPC-2 Persistence Test was approved for use in this set of audited measurements.

In some cases the same address was the target of multiple writes, which resulted in more Logical Blocks Written than Logical Blocks Verified. In the case of multiple writes to the same address, the pattern written and verified must be associated with the last write to that address.

# PRICED STORAGE CONFIGURATION AVAILABILITY DATE

# APPENDIX A: SPC-1 GLOSSARY

### "Decimal" (powers of ten) Measurement Units

In the storage industry, the terms "kilo", "mega", "giga", "tera", "peta", and "exa" are commonly used prefixes for computing performance and capacity. For the purposes of the SPC workload definitions, all of the following terms are defined in "powers of ten" measurement units.

A kilobyte (KB) is equal to  $1,000 (10^3)$  bytes.

A megabyte (MB) is equal to 1,000,000 (10<sup>6</sup>) bytes.

A gigabyte (GB) is equal to 1,000,000,000 (10<sup>9</sup>) bytes.

A terabyte (TB) is equal to 1,000,000,000,000 (10<sup>12</sup>) bytes.

A petabyte (PB) is equal to 1,000,000,000,000,000 (10<sup>15</sup>) bytes

An exabyte (EB) is equal to 1,000,000,000,000,000 (10<sup>18</sup>) bytes

### "Binary" (powers of two) Measurement Units

The sizes reported by many operating system components use "powers of two" measurement units rather than "power of ten" units. The following standardized definitions and terms are also valid and may be used in this document.

A kibibyte (KiB) is equal to 1,024 (2<sup>10</sup>) bytes.

A mebibyte (MiB) is equal to 1,048,576 (2<sup>20</sup>) bytes.

A gigibyte (GiB) is equal to 1,073,741,824 (2<sup>30</sup>) bytes.

A tebibyte (TiB) is equal to 1,099,511,627,776 (2<sup>40</sup>) bytes.

A pebibyte (PiB) is equal to 1,125,899,906,842,624 (2<sup>50</sup>) bytes.

An exbibyte (EiB) is equal to 1,152,921,504,606,846,967 (2<sup>60</sup>) bytes.

## **SPC-1 Data Repository Definitions**

**Total ASU Capacity:** The total storage capacity read and written in the course of executing the SPC-1 benchmark.

**Application Storage Unit (ASU):** The logical interface between the storage and SPC-1 Workload Generator. The three ASUs (Data, User, and Log) are typically implemented on one or more Logical Volume.

**Logical Volume:** The division of Addressable Storage Capacity into individually addressable logical units of storage used in the SPC-1 benchmark. Each Logical Volume is implemented as a single, contiguous address space.

**Addressable Storage Capacity:** The total storage (sum of Logical Volumes) that can be read and written by application programs such as the SPC-1 Workload Generator.

**Configured Storage Capacity:** This capacity includes the Addressable Storage Capacity and any other storage (parity disks, hot spares, etc.) necessary to implement the Addressable Storage Capacity.

**Physical Storage Capacity:** The formatted capacity of all storage devices physically present in the Tested Storage Configuration (TSC).

**Data Protection Overhead:** The storage capacity required to implement the selected level of data protection.

**Required Storage:** The amount of Configured Storage Capacity required to implement the Addressable Storage Configuration, excluding the storage required for the three ASUs.

**Global Storage Overhead:** The amount of Physical Storage Capacity that is required for storage subsystem use and unavailable for use by application programs.

**Total Unused Storage:** The amount of storage capacity available for use by application programs but not included in the Total ASU Capacity.

# **SPC-1 Data Protection Levels**

**Protected 1:** The single point of failure of any *storage device* in the configuration will not result in permanent loss of access to or integrity of the SPC-1 Data Repository.

**Protected 2:** The single point of failure of any *component* in the configuration will not result in permanent loss of access to or integrity of the SPC-1 Data Repository.

## **SPC-1 Test Execution Definitions**

**Average Response Time:** The sum of the Response Times for all Measured I/O Requests divided by the total number of Measured I/O Requests.

**Completed I/O Request:** An I/O Request with a Start Time and a Completion Time (see "I/O Completion Types" below).

**Completion Time:** The time recorded by the Workload Generator when an I/O Request is satisfied by the TSC as signaled by System Software.

**Data Rate**: The data transferred in all Measured I/O Requests in an SPC-1 Test Run divided by the length of the Test Run in seconds.

**Expected I/O Count:** For any given I/O Stream and Test Phase, the product of 50 times the BSU level, the duration of the Test Phase in seconds, and the Intensity Multiplier for that I/O Stream.

**Failed I/O Request:** Any I/O Request issued by the Workload Generator that could not be completed or was signaled as failed by System Software. A Failed I/O Request has no Completion Time (see "I/O Completion Types" below).

**I/O Request Throughput:** The total number of Measured I/O requests in an SPC-1 Test Run divided by the duration of the Measurement Interval in seconds.

**In-Flight I/O Request:** An I/O Request issued by the I/O Command Generator to the TSC that has a recorded Start Time, but does not complete within the Measurement Interval (see "I/O Completion Types" below).

**Measured I/O Request:** A Completed I/O Request with a Completion Time occurring within the Measurement Interval (see "I/O Completion Types" below).

**Measured Intensity Multiplier:** The percentage of all Measured I/O Requests that were issued by a given I/O Stream.

**Measurement Interval:** The finite and contiguous time period, after the TSC has reached Steady State, when data is collected by a Test Sponsor to generate an SPC-1 test result or support an SPC-1 test result.

**Ramp-Up:** The time required for the Benchmark Configuration (BC) to produce Steady State throughput after the Workload Generator begins submitting I/O Requests to the TSC for execution.

**Ramp-Down:** The time required for the BC to complete all I/O Requests issued by the Workload Generator. The Ramp-Down period begins when the Workload Generator ceases to issue new I/O Requests to the TSC.

**Response Time:** The Response Time of a Measured I/O Request is its Completion Time minus its Start Time.

**Start Time:** The time recorded by the Workload Generator when an I/O Request is submitted, by the Workload Generator, to the System Software for execution on the Tested Storage Configuration (TSC).

**Start-Up:** The period that begins after the Workload Generator starts to submit I/O requests to the TSC and ends at the beginning of the Measurement Interval.

**Shut-Down:** The period between the end of the Measurement Interval and the time when all I/O Requests issued by the Workload Generator have completed or failed.


**Steady State:** The consistent and sustainable throughput of the TSC. During this period the load presented to the TSC by the Workload Generator is constant.

Test: A collection of Test Phases and or Test Runs sharing a common objective.


**Test Run:** The execution of SPC-1 for the purpose of producing or supporting an SPC-1 test result. SPC-1 Test Runs may have a finite and measured Ramp-Up period, Start-Up period, Shut-Down period, and Ramp-Down period as illustrated in the "SPC-1 Test Run Components" below. All SPC-1 Test Runs shall have a Steady State period and a Measurement Interval.

**Test Phase:** A collection of one or more SPC-1 Test Runs sharing a common objective and intended to be run in a specific sequence.

## **Storage Array Volume Creation**

The storage management utility software, **SANtricity**, is installed on both Host Systems. It is a required software package that provides configuration, monitoring, and failover path management. The software is installed as a Windows installable package.

After installation, it can be found in **\Program Files (x86)\StorageManager\client** and is typically started with **Start**->**All Programs**->**SANtricity Storage Manager** ->**SANtricity Storage Manager Storage Storage Manager Storage Manager Storage Storage Manager Storage Stora** 

The **SANtricity Storage Manager** was used to create 3 volume groups on the storage subsystem. Each volume group contains two RAID1 (*mirrored*) volumes. All 6 RAID1 volumes are visible by each Host System.

The physical storage volumes are created on the storage array using the **SANtricity Storage Manager** script editor as follows:

- Launch SANtricity Storage Manager.
- From the Enterprise Management window, right-click the name of the storage array that you will be creating volumes on and select *Execute Script* from the pop-up menu.
- In the Script Editor window, load the <u>SPC1\_RAID\_Config.script</u> script (listed at the end of this appendix).
- Once the script is loaded, select *Execute* from the Tools menu.

### SPC-1 Logical Volume Creation

The steps that follow are executed on a single Host System to define the Windows partitions, volumes, and stripe sets that comprise the SPC-1 Logical Volumes/Application Storage Units (ASUs).

- 1. Start the Windows Disk Administrator, which will automatically discover the six RAID volumes, and then exit the Disk Administrator.
- 2. Use **diskpar.exe** to set the starting offset for each of the storage system volumes. Starting offset is 65536 sectors (512 bytes per sector). Use all of the remaining capacity to create a single volume in each partition.
- 3. Start the Disk Management utility under Computer Management.
- 4. Convert all of the storage system volumes to Dynamic Disks.
- 5. Create a Windows Striped (RAID 0) volume using all six 32 MB partitions.
- 6. Delete the remaining large volume on each of the Dynamic Disks.
- 7. Create a Windows Striped (RAID 0) volume for ASU 3.
  - a. Select all six volumes.
  - b. Set capacity to 71,574 MB (MiB).
  - c. Assign drive letter "T" to the volume. Do not format the volume.
- 8. Create a Windows Striped (RAID 0) volume for ASU 1.
  - a. Select all six volumes.
  - b. Set capacity to 322,083 MB (MiB).
  - c. Assign drive letter "R" to the volume. Do not format the volume.
- 9. Create a Windows Striped (RAID 0) volume for ASU 2.
  - a. Select all six volumes.
  - b. Set capacity to 322,083 MB (*MiB*).
  - c. Assign drive letter "S" to the volume. Do not format the volume.
- 10. Reboot the Host Systems.
- 11. After each reboot completes, start the Disk Administrator utility on each of the Host Systems.
- 12. On each Host System, select either the import foreign disk or reactivate Windows stripe sets option, as necessary, then assign drive letters to the stripe sets as they were assigned in steps 7-9 above.
