










SPC-1 Storage Capacity Charts



Sustainability - I/O Request Throughput Distribution Graph





Sustainability - Average Response Time (ms) Distribution Graph





IOPS Test Run - I/O Request Throughput Distribution Graph





IOPS Test Run - Average Response Time (ms) Distribution Graph



Primary Metrics Test - Response Time Ramp Test Phase

Clause 5.4.4.3

The Response Time Ramp Test Phase consists of five Test Runs, one each at 95%, 90%, 80%, 50%, and 10% of the load point (100%) used to generate the SPC-1 IOPSTM primary metric. Each of the five Test Runs has a Measurement Interval of ten (10) minutes. The Response Time Ramp Test Phase immediately follows the IOPS Test Phase without any interruption or manual intervention.

The five Response Time Ramp Test Runs, in conjunction with the IOPS Test Run (100%), demonstrate the relationship between Average Response Time and I/O Request Throughput for the Tested Storage Configuration (TSC) as illustrated in the response time/throughput curve on page 15.

In addition, the Average Response Time measured during the 10% Test Run is the value for the SPC-1 LRT^{TM} metric. That value represents the Average Response Time of a lightly loaded TSC.



Response Time Ramp Distribution (IOPS) Graph



Repeatability 1 LRT - I/O Request Throughput Distribution Graph




Repeatability 1 LRT -Average Response Time (ms) Distribution Graph


Repeatability 1 IOPS - I/O Request Throughput Distribution Graph

Repeatability 1 IOPS -Average Response Time (ms) Distribution Graph



Repeatability 2 LRT - I/O Request Throughput Distribution Graph




Repeatability 2 LRT -Average Response Time (ms) Distribution Graph

Repeatability 2 IOPS - I/O Request Throughput Distribution Graph





Data Persistence Test

Clause 6

The Data Persistence Test demonstrates the Tested Storage Configuration (TSC):

- Is capable of maintain data integrity across a power cycle.
- Ensures the transfer of data between Logical Volumes and host systems occurs without corruption or loss.

The SPC-1 Workload Generator will write 16 block I/O requests at random over the total Addressable Storage Capacity of the TSC for ten (10) minutes at a minimum of 25% of the load used to generate the SPC-1 IOPSTM primary metric. The bit pattern selected to be written to each block as well as the address of the block will be retained in a log file.

The Tested Storage Configuration (TSC) will be shutdown and restarted using a power off/power on cycle at the end of the above sequence of write operations. In addition, any caches employing battery backup must be flushed/emptied.

The SPC-1 Workload Generator will then use the above log file to verify each block written contains the correct bit pattern.

APPENDIX A: SPC-1 GLOSSARY

"Decimal" (powers of ten) Measurement Units

In the storage industry, the terms "kilo", "mega", "giga", "tera", "peta", and "exa" are commonly used prefixes for computing performance and capacity. For the purposes of the SPC workload definitions, all of the following terms are defined in "powers of ten" measurement units.

A kilobyte (KB) is equal to 1,000 (10³) bytes.

A megabyte (MB) is equal to 1,000,000 (106) bytes.

A gigabyte (GB) is equal to 1,000,000,000 (109) bytes.

A terabyte (TB) is equal to 1,000,000,000,000 (10¹²) bytes.

A petabyte (PB) is equal to 1,000,000,000,000,000 (10¹⁵) bytes

An exabyte (EB) is equal to 1,000,000,000,000,000,000 (1018) bytes

"Binary" (powers of two) Measurement Units

The sizes reported by many operating system components use "powers of two" measurement units rather than "power of ten" units. The following standardized definitions and terms are also valid and may be used in this document.

A kibibyte (KiB) is equal to 1,024 (210) bytes.

A mebibyte (MiB) is equal to 1,048,576 (2^{20}) bytes.

A gigibyte (GiB) is equal to 1,073,741,824 (230) bytes.

A tebibyte (TiB) is equal to 1,099,511,627,776 (240) bytes.

A pebibyte (PiB) is equal to 1,125,899,906,842,624 (2⁵⁰) bytes.

An exhibite (EiB) is equal to 1,152,921,504,606,846,967 (260) bytes.

SPC-1 Data Repository Definitions

Total ASU Capacity: The total storage capacity read and written in the course of executing the SPC-1 benchmark.

Application Storage Unit (ASU): The logical interface between the storage and SPC-1 Workload Generator. The three ASUs (Data, User, and Log) are typically implemented on one or more Logical Volume.

Logical Volume: The division of Addressable Storage Capacity into individually addressable logical units of storage used in the SPC-1 benchmark. Each Logical Volume is implemented as a single, contiguous address space.

Addressable Storage Capacity: The total storage (sum of Logical Volumes) that can be read and written by application programs such as the SPC-1 Workload Generator.

Configured Storage Capacity: This capacity includes the Addressable Storage Capacity and any other storage (parity disks, hot spares, etc.) necessary to implement the Addressable Storage Capacity.

Physical Storage Capacity: The formatted capacity of all storage devices physically present in the Tested Storage Configuration (TSC).

Data Protection Overhead: The storage capacity required to implement the selected level of data protection.

Required Storage: The amount of Configured Storage Capacity required to implement the Addressable Storage Configuration, excluding the storage required for the three ASUs.

Global Storage Overhead: The amount of Physical Storage Capacity that is required for storage subsystem use and unavailable for use by application programs.

Total Unused Storage: The amount of storage capacity available for use by application programs but not included in the Total ASU Capacity.

SPC-1 Data Protection Levels

Protected 1: The single point of failure of any *storage device* in the configuration will not result in permanent loss of access to or integrity of the SPC-1 Data Repository.

Protected 2: The single point of failure of any *component* in the configuration will not result in permanent loss of access to or integrity of the SPC-1 Data Repository.

SPC-1 Test Execution Definitions

Average Response Time: The sum of the Response Times for all Measured I/O Requests divided by the total number of Measured I/O Requests.

Completed I/O Request: An I/O Request with a Start Time and a Completion Time (see "I/O Completion Types" below).

Completion Time: The time recorded by the Workload Generator when an I/O Request is satisfied by the TSC as signaled by System Software.

Data Rate: The data transferred in all Measured I/O Requests in an SPC-1 Test Run divided by the length of the Test Run in seconds.

Expected I/O Count: For any given I/O Stream and Test Phase, the product of 50 times the BSU level, the duration of the Test Phase in seconds, and the Intensity Multiplier for that I/O Stream.

Failed I/O Request: Any I/O Request issued by the Workload Generator that could not be completed or was signaled as failed by System Software. A Failed I/O Request has no Completion Time (see "I/O Completion Types" below).

I/O Request Throughput: The total number of Measured I/O requests in an SPC-1 Test Run divided by the duration of the Measurement Interval in seconds.

In-Flight I/O Request: An I/O Request issued by the I/O Command Generator to the TSC that has a recorded Start Time, but does not complete within the Measurement Interval (see "I/O Completion Types" below).

Measured I/O Request: A Completed I/O Request with a Completion Time occurring within the Measurement Interval (see "I/O Completion Types" below).

Measured Intensity Multiplier: The percentage of all Measured I/O Requests that were issued by a given I/O Stream.

Measurement Interval: The finite and contiguous time period, after the TSC has reached Steady State, when data is collected by a Test Sponsor to generate an SPC-1 test result or support an SPC-1 test result.

Ramp-Up: The time required for the Benchmark Configuration (BC) to produce Steady State throughput after the Workload Generator begins submitting I/O Requests to the TSC for execution.

Ramp-Down: The time required for the BC to complete all I/O Requests issued by the Workload Generator. The Ramp-Down period begins when the Workload Generator ceases to issue new I/O Requests to the TSC.

Response Time: The Response Time of a Measured I/O Request is its Completion Time minus its Start Time.

Start Time: The time recorded by the Workload Generator when an I/O Request is submitted, by the Workload Generator, to the System Software for execution on the Tested Storage Configuration (TSC).

Start-Up: The period that begins after the Workload Generator starts to submit I/O requests to the TSC and ends at the beginning of the Measurement Interval.

Shut-Down: The period between the end of the Measurement Interval and the time when all I/O Requests issued by the Workload Generator have completed or failed.


Steady State: The consistent and sustainable throughput of the TSC. During this period the load presented to the TSC by the Workload Generator is constant.

Test: A collection of Test Phases and or Test Runs sharing a common objective.


Test Run: The execution of SPC-1 for the purpose of producing or supporting an SPC-1 test result. SPC-1 Test Runs may have a finite and measured Ramp-Up period, Start-Up period, Shut-Down period, and Ramp-Down period as illustrated in the "SPC-1 Test Run Components" below. All SPC-1 Test Runs shall have a Steady State period and a Measurement Interval.

Test Phase: A collection of one or more SPC-1 Test Runs sharing a common objective and intended to be run in a specific sequence.

Windows Server 2008 Power Options

APPENDIX C: TESTED STORAGE CONFIGURATION (TSC) CREATION

Storage Array Management

The EMC Storage Management CLI utility, **Navisphere CLI**, is installed on a server which has network connection to EMC VNX8000 Storage Processor. Navisphere CLI commands are executed by using the following syntax:

naviseccli –h <lPaddress> –user <username> -password <password> -scope 0 CMD <optional arguments>

CMD refers to the set of commands that can be used with the **Navisphere CLI** utility.

The **Navisphere CLI** utility is available as a free download from the EMC support website for customers with an EMC account.

Extended Cache

VNX8000 Extended Cache Enabler was installed on the TSC to maximize system cache capacity, as no data services were included in the configuration.

In the general case, system memory space is shared by the cache and data services, with each receiving an allocation. However, if data services are not required in a specific deployment, the **VNX8000 Extended Cache Enabler** can be used to allocate the full available memory space to cache, as any allocated to data services would not be used.

In a customer engagement for a new system, EMC account and field support staff review the intended configuration, application, and use cases and determine if the Extended Cache feature is appropriate for that deployment and if it would provide a benefit. If so, they would inform the customer and recommend that it to be included.

The VNX8000 Extended Cache Enabler is available to EMC customers through EMC Request for Product Qualification (RPQ) at no cost. EMC field support staff follows the standard RPQ process by including the proper documentation with the order. This is reviewed and approved by Product Management, and the VNX8000 Extended Cache Enabler software package is provided.

To install the enabler using the EMC **Navisphere CLI**, which will reconfigure the memory space, the following *naviseccli* command is used:

naviseccli –h <lPaddress> -user <user> -password <password> -scope 0 ndu –install ExtendedCacheEnabler-01.01.5.001-armada64 free.ena

The enabler can also be installed and memory space reconfigured through the EMC standard management software, **Unisphere Service Manager** (USM), via a GUI.

The **Unisphere Service Manager** is also available as a free download from the EMC support website for customers with an EMC account.

Either EMC field support staff or the customers themselves can install the enabler.

Storage Configuration

The steps to configure the TSC are summarized below. Referenced scripts, with the appropriate *naviseccli* commands, are executed in a Windows command prompt window on a server as described above in the <u>Storage Array Management</u> section.

Each referenced script appears below in the Referenced Scripts section.

- 1. Change Windows 2008 Server Power Option to **High performance** on each of the 16 Host Systems as described in <u>Appendix B: Customer Tunable Parameters and Options</u>.
- 2. Install **VNX8000 Extended Cache Enabler** as as described in the above <u>Extended</u> Cache section.
- 3. Execute the **hotspare.bat** script to set hot spare policy for SSDs to remove the requirement for hot spare drives.
- 4. Execute the <u>create pool.bat</u> script to create 1 Storage Pool using all 40 SSD drives with RAID 1/0.
- 5. After the Storage Pool is created, execute the <u>create_LUNs.bat</u> script to create 15 LUNs in the Storage Pool, which are the SPC-1 Logical Volumes (5 logical volumes for each of the three ASUs).
- 6. Execute the <u>create storagegroup.bat</u> script to create a Storage Group to control the the Host Systems' access to all 15 LUNs.
- 7. Execute the <u>sethost_failover.bat</u> script to set all Host Systems' failover mode to be 0, the basic mode which doesn't require multipathing software to be installed.
- 8. Execute the <u>addHost to Storagegroup.bat</u> script to add all 16 Host Systems to the Storage Group.
- 9. Execute the <u>addLUN to Storagegroup.bat</u> script to add all 15 LUNs to the Storage Group.
- 10. Reboot the 16 Host Systems to discover the LUNs.
